The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. Submission of bids physically is not permitted.
- 2. The intending bidder must read the terms & conditions of CPWD-6 carefully. He / She should only submit his bid if, he /she consider himself / herself eligible and he / she is in possession of all the documents required.
- 3. Information and Instructions for bidders posted on website shall form part of bid document.
- **4.** The bid / tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of the terms and conditions of the contract to be compiled with and other necessary documents can be seen and downloaded from website www.tripuratenders.gov.in or www.tenders.gov.in free of cost.
- 5. (i) Earnest money @1% of the estimated cost value (ECV) put to tender shall be drawn in favour of the Executive Engineer, DWS Store Division, Agartala, West Tripura in the form of Deposit -at- Call receipt or Demand Draft of any Schedule Bank guaranteed by the Reserve Bank of India which shall be scanned and uploaded to the e-Procurement website www.tripuratenders.gov.in within the period of bid submission. Earnest Money in any other form will not be accepted. The earnest money deposited by the tenderer will not carry any interest. The tenderers exempted from depositing earnest money in individual case by any order of State / Central Government, PSU, Local SSI etc. shall also have to deposit the stipulated amount of earnest money. In general, earnest money shall be deposited by the tenderers in every case. No claim / plea of the tenderers in this respect will be entertained.

- (ii) Interested tenderers who intend to participate in the bid has also to make payment amounting to ₹5000.00 (Rupees Five Thousand) only being the bid fee in the form of Deposit- at- call / Demand Draft of any Schedule Bank guaranteed by the Reserve Bank of India drawn in favour of the Executive Engineer, DWS Store Division, Agartala, West Tripura and to be scanned and uploaded to the e-Procurement website www.tripuratenders.gov.in within the period of bid submission. Bid Fee as above is Non-Refundable. The tenderers exempted from depositing Bid fee in individual case by any order of State / Central Government, PSU etc. shall also have to deposit the stipulated amount of bid fee. In general, Bid fee shall be deposited by the tenderers in every case. No claim/ plea of the tenderers in this respect will be entertained.
- (iii) Demand drafts furnished towards earnest money along with the tender shall be valid for a period of 3 (three) months from the last date of receipt of tender.
- (iv) Prior to expiry of validity of the Demand Draft submitted along with the tender towards earnest money, if it is asked by the tender inviting authority, the tenderer shall furnish another Demand draft towards stipulated earnest money having validity for further three months period so that total validity period of earnest money furnished through demand draft shall be ensured at least for the stipulated tender validity period. However, the Demand draft furnished along with the tender shall be returned to the tenderer on receipt of fresh Demand draft with required validity as noted above.
- **6.** Those contractors not registered on the website mentioned above, are required to get registered beforehand.
- 7. To participate in e-tender, the bidder shall have at least valid Class 2 / Class 3 Digital Signature Certificate.
- **8.** The bidder / tenderer can upload documents in the form of JPG format and PDF format (in 100 dpi scan resolution).
- **9.** List of documents to be scanned & uploaded within the period of bid submission:
