The Deposit-at-call or Demand Draft must be submitted along with the tender.

Tender documents shall be issued on payment of a sum of ₹ 500.00 (for estimated cost up to 1.00 Lakh) only and ₹ 1,000.00 (for estimated cost over 1.00 Lakh up to 50.00 Lakhs) in cash each (non-refundable) on any working days as specified above on production of documentary of i) Nationality, PTCC, ii) STCC, iii) PAN (Permanent Account Number) card, iv) valid license regarding engagement of workers in the contract works from Labour Department Government of Tripura, v) Electrical Contractor's License & Enlistment of the firm/ Contractor, vi) GST registration along with an application.

Demand drafts furnished towards Earnest Money along with the tender shall be valid for a period of 03(three) months from the last date of receipt of tender or more.

Tender(s) can be sent through Registered Post/Speed Post or dropped in the tender box/boxes at the office of the **Executive Engineer, Internal Electrification Division, Agartala, West Tripura** so as to reach or dropped well within the last date for receipt as specified above. Sealed tender(s) received shall be opened by the **Executive Engineer, Internal Electrification Division, Agartala, West Tripura**, in presence of intending tenderers and other tenderers who may like to remain present.
