Demand drafts furnished as above shall be valid for a minimum period of 3 (three) months from the last date of publishing of bid. Bid Fee of ₹ 2,500.00 (Rupees two thousand five hundred) only, shall be accepted as "Deposit at call" / "Demand Draft" and is Non-Refundable.
