

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **Rs.2500.00 (Rupees two thousand five hundred)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.
