Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "Deposit at call"/ "Demand Draft" in favour of the **Executive Engineer, Agartala Division No.I, PWD(R&B), Agartala, Tripura (West)**.

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **Rs.1,000.00 (Rupees one thousand)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.
