REQUEST FOR EXPRESSIONS OF INTEREST (CONSULTANCY SERVICES)

Assignment Title: - Consultancy services for Preliminary and Detailed Engineering including preparation of Detailed Project for Construction of 17(Seventeen) nos. of permanent bridges at different location on the State Road Network.

The Government of Tripura has decided to procure the intended Consultancy Services for preliminary and detailed engineering including preparation of Detailed Project Report (DPR) for construction of **17 (seventeen)** numbers of permanent bridges at different locations on road network in the state of Tripura. The consultancy services ("the Services") include:-

(i) The nature of services provided by the consultant will be limited to survey and investigation of bridge sites, soil investigation, material survey, study on quarry in exploring suitable road and bridge construction materials, collection of all other relevant data as required in preparing the Detailed Project Report strictly in conformity with latest revision of MoRT&H & IRC guidelines, preparation of detail design and drawings, estimates, bill of quantities etc.

The department will provide the list of bridges proposed for investigation along with the relevant data if available to the consultant.

(ii) These services are expected to be delivered over a period of **4 (four) months**.

The indicative Terms of Reference (ToR) subject to modification & finalization before issuing of Request for Proposal (RFP), for the assignment are available at the **e-procurement website <https://tripuratenders.gov.in>**. The Tripura Public Works Department now invites eligible consulting firms ("Consultants"), to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are given in the Expression of Interest (EoI). The EoI includes the following documents:-
