- The earnest money have to be in the shape of Fixed Deposit Receipt (FDR) / Demand Draft (DD) / Deposit at Call from any Scheduled Commercial Bank drawn in favour of Empowered Officer, TRRDA,PWD(PMGSY), Tripura and payable at SBI, Kunjavan, Agartala.
- 5. **Availability of Bid Document and mode of submission**: The bid document is available online and bid should be submitted online on website <a href="www.pmgsytenderstrp.gov.in">www.pmgsytenderstrp.gov.in</a>. The bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have valid Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). "Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in PMGSY may obtain the same from the website: <a href="www.pmgsytenderstrp.gov.in">www.pmgsytenderstrp.gov.in</a>.

Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the valid digital signature issued from authorized CAs can use the same in this tender.

- 6. Submission of Original Documents: The bidders are required to submit (a) original Demand Draft towards the cost of bid document and (b) original bid security in approved form and (c) original affidavit regarding correctness of information furnished with bid document as per provisions of Clause 4.4B(a) (ii) of ITB with the Empowered Officer, TRRDA, PWD(PMGSY), 7th Block,2nd Floor, Secretariat Building, Agartala, upto or before the time and date of submission of bids either by registered post or by hand, failing which the bids shall be declared non-responsive.
- 7. Last Date/ Time for receipt of bids through e-tendering: 19/11/2019 up-to 1500 Hours
- **8.** The site for the work is available.

- 9. Only online submission of bids is permitted, therefore; bids must be submitted online on website <a href="https://www.pmgsytenderstrp.gov.in">www.pmgsytenderstrp.gov.in</a> The technical qualification part of the bids will be opened online at 1530 Hours on 19/11/2019 (if possible) by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day at the same time.
- 10. The bidder is not required to quote his rate for routine maintenance. The cost of annual maintenance for five year shall be fixed and pre declared by the department. The rates to be paid for routine maintenance are indicated in the Bill of Quantities. Further, the payment for routine maintenance to the contractor shall be regulated based on his performance of maintenance activities.
- 11. The bids for the work shall remain valid for acceptance for a period not less than ninety days after the deadline date for bid submission.
- 12. Bidders may bid for any one or more of the works mentioned in the Table above. To qualify for a package of contracts made up of this and other contracts for which bids are invited in the same NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
- 13. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tender.
