TERMS AND CONDITIONS:

1. The agency should produce the record of availability of vehicles specially M&M Scorpio, Bolero, Maruti Swift Dzire, Maruti Omni and Maruti Eeco along with their Commercial Permit, Pollution, Insurance certificate and Road Tax papers.
2. Solvency Certificate from bank (Rs.10 lakh) must be produced
3. The hiring charges of vehicle should not exceed the guideline of the Finance Department, Govt. of Tripura.
4. Number of vehicles (one or more) to be hired based on requirement.
5. **EMD for Rs.10, 000/-** in the form of DD/Cheque drawn in favour of the Director, Information & Cultural Affairs, Govt. of Tripura is to be submitted along with the tender. If, '**MSME**' registered then the certificate must be produced.
6. The envelope containing the quotation should be properly sealed and subscribed in bold letters on the top as "**QUOTATION OF VEHICLE- M&M Scorpio, Bolero, Swift Dzire, Maruti Omni, Eeco**" be dropped in the tender box which will be kept in the office premises from **23rd Sept. 2020** to **01st Oct. 2020**. The last date of submission of quotation is **01st Oct. 2020** up to **5 P.M.**
7. The date of opening of the Tender Box is **03rd Oct. 2020** at **1 P.M** at the Office of the Directorate of ICA, Agartala.
8. Interested bidders, their authorized representatives may remain present during opening of the tender.
9. No tender will be received or accepted after the due date and time as mentioned above.
10. The vehicle should be provided with driver having self driving license of the driver;
11. The vehicle should be provided with KM cable in operating condition always;
12. The vehicle will have to run in all weather and on all kinds of road in plain and hill areas.
13. A Log Book is to be maintained where journey, locations, KM run etc. will be recorded by the driver of the vehicle and to be signed by travelling person after completion of duty;
14. Bill in triplicate along with copy of 'Log Book' and work order may be submitted for payment within 07(seven) days after the journey;
15. In case the vehicle needs any maintenance, the agency should place alternative vehicle of equal model/manufacturer till it is not fit for journey;
16. Half an hour/1(one) hour prior intimation will be given if the vehicle is not required vice-versa.
17. The Detention charge, Per Kilometer Charge and the night hold charge will be as per quotation.
18. No correspondence shall be entertained with any applicants after opening of quotation, except with successful bidder.
19. If the vehicle remains off on the road for more than 2 hours, the concerned agency have to arrange another vehicle at his own cost and risk failing which ICA Department may arrange another vehicle at the cost of the owner of the contracted vehicle.
