The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. **Submission of bids physically is not permitted.**

Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "Deposit at call"/ "Demand Draft" in favour of the **Executive Engineer, Teliamura Division, PWD(R&B), Teliamura, Khowai District, Tripura.**

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **₹5,000.00 (Rupees five thousand)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.

The Bidders will have to upload the scan copy of the drawn "Demand Draft"/ "Deposit at call" (as a single PDF file of 100 dpi resolution), against the related Bid fee & Earnest money, along with the bid.
