- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid / tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of the terms and conditions of the contract to be compiled with and other necessary documents can be seen and downloaded from website www.tripuratenders.gov.in free of cost.

6. Earnest money are to be paid electronically over the Online Payment facility provided in the Portal, any time after Bid Submission Start Date & before Bid Submission End Date, using the supported Payment Mode (**Net Banking**).

Tender Fee (Non-refundable) are to be paid electronically over the Online Payment facility provided in the Portal, any time after Bid Submission Start Date & before Bid Submission End Date, using the supported Payment Mode (Net Banking) and to be deposited to the Government account automatically as revenue.
8. To participate in e-tender, the bidder shall have at least valid Class 2 / Class 3 Digital Signature Certificate (DSC).
9. The bidder / tenderer can upload documents in the form of PDF format (in 100 dpi scan resolution).
10. On opening date, the contractor can login and see the bid opening process. After opening of bids he / she will receive the competitor bid sheets.
11. Bill of Quantity (BOQ), which is the Rate quoting sheet in Ms-excel shall be downloaded, filled up properly and uploaded in the bid after digital signing. The Bidder shall always open the BOQ sheet with Macros Enabled.
